IMPORTANT TO NOTE:

- Terms of payment are 30 days from date of invoice. The Club offers a debit order facility whereby membership fees can be paid off in 12 equal instalments at an additional 5% of the total membership fee - fees must be fully paid by the end of June of the following year. Returned debit orders are due immediately via EFT, failing which the Club will suspend your membership until such time as you are in goodstanding. Should you wish to make use of this facility, please notify our membership secretary when handing in this form and we will email an electronic debit order mandate to you from Netcash for online authorisation.
- Our membership year runs from 1 July to 30 June each year. *Your membership is continuous and will only be cancelled if the member informs us in writing via email to membership@rcyc.co.za before the end of the current membership year.* Should you fail to notify us of your wish to terminate your membership before the end of June, you will be liable for the next full year's membership, whether you pay your annual subscription in one lump sum or over 12 months via debit order.
- An administration fee of 5% will be levied to members who resign in bad standing, or are struck off our membership role.

PROTECTION OF PERSONAL INFORMATION ACT 4 OF 2013 CONSENT:
